



TERMS AND CONDITIONS

BSN - MYDIN Spend and Redeem Campaign

1. THE CAMPAIGN

The **BSN – MYDIN Spend and Redeem Campaign** (“Campaign”), organized by Bank Simpanan Nasional (“BSN”) shall commence from **1st May 2018 until 30th June 2018**, both dates inclusive (“Campaign Period”) unless notified otherwise.

2. ELIGIBILITY

- 2.1 This Campaign is open to all eligible new and existing BSN Credit and Debit Card(s) (“BSN Card(s)”) Cardmember (“Eligible Cardmember(s)”).
- 2.2 Eligible Cardmember means cardmember whose account is current, good standing and not closed, cancelled, suspended or terminated by BSN.
- 2.3 Notwithstanding the above, BSN shall have the sole and absolute discretion to decide on the eligibility criteria of the Eligible Cardmembers for the Campaign.

3. CAMPAIGN OFFER AND CRITERIA

- 3.1 Eligible Cardmember with a minimum spend of RM100 in a single receipt at any 25 participating MYDIN Hypermarkets nationwide as per Clause 3.3 is entitled to redeem one (1) pack of **200g VICO Chocolate Malt Food Drink** (“Gift Redemption”).
- 3.2 Gift Redemption will be awarded to all Eligible Cardmember as per the criteria below:-
 - (a) Payment must be made by using BSN Cards. Limited to one (1) gift redemption per Cardmember per day, while stock last.
 - (b) Redemption must be made at respective MYDIN Hypermarket Redemption Counter where the purchase is made on the same day only.
 - (c) Minimum spending of RM100 must be made in a single receipt.
 - (d) Cardmembers are required to present the BSN Card and the original receipt during gift redemption.
 - (e) Gift cannot be exchanged for cash or for any other products.
 - (f) BSN does not warrant nor liable for any damage or bodily injury occasioned by the use or consumption of the gift and neither represent the quality or fitness for any purpose of the gift.

(g) BSN reserves the right to substitute the gift with other item if the gift is not available for whatsoever reason.

4. GENERAL TERMS & CONDITIONS

- 4.1 By participating in this Campaign, the Eligible Cardmembers agree:-
- (a) To be bound by these Terms and Conditions (T&Cs) of the Campaign, General T&Cs of the BSN Cards and/or any other relevant T&Cs that BSN may impose from time to time;
 - (b) To access to BSN's Website on regular basis to ensure that the Eligible Cardmember is updated with any change or variation made to the T&Cs.
 - (c) All BSN's decisions on all matters relating to the Campaign and Gift shall be final, conclusive and binding on all Cardmembers. No further correspondence and/or appeal to dispute the same will be entertained.
- 4.2 Eligible Cardmember also agrees and consent for their personal details including but not limited to personal data or information being collected, processed and used by BSN for the purposes of the Campaign.
- 4.3 BSN reserves the right to vary, delete, add or amend any of these T&Cs contained herein, wholly or in part by giving at least a minimum of twenty-one (21) calendar days prior notice. BSN may give such notice or communication to Eligible Cardmembers by posting at BSN's Website, by post, by notification in the mass media, by posting the notice in the BSN's branches or by electronic transmission or any other method that BSN think appropriate.
- 4.4 The T&Cs of this Campaign is an addition to the General T&Cs applicable to the BSN Cards. In the event of discrepancy between the T&Cs of this Campaign and the General T&Cs to the BSN Cards, these T&Cs shall prevail in so far as they apply to this Campaign.
- 4.5 In the event of any discrepancy between the T&Cs and any advertising, promotional, publicity and other materials relating to or in connection with the Campaign, the final T&Cs on the BSN's Website shall prevail. Any matter with regards to the Campaign which is not covered in these T&Cs will be determined solely by BSN at its discretion.
- 4.6 BSN at its discretion may withdraw, cancel or suspend the Campaign earlier than the Campaign Period or extend the Campaign beyond the Campaign Period by giving at least a minimum of twenty-one (21) calendar days prior notice.
- 4.7 BSN shall not be responsible and/or liable nor shall it accept any form of liability whatsoever nature and howsoever arising or suffered by Eligible Cardmember resulting directly or indirectly from the participation in the Campaign or otherwise. Furthermore, BSN shall not be liable for any default of its obligation under the Campaign due to any force majeure event which include but not limited to act of God, war, riot, lockout, industrial action, fire, flood, drought, storm or any event beyond the reasonable control of BSN.

- 4.8 These T&Cs shall be governed and construed in accordance by the Laws of Malaysia and subject to the exclusive jurisdiction of the Courts of Malaysia.
