

## **Giant-Visa Spend and Win Contest** **Terms and Conditions**

By participating in the Giant – Visa Spend & Win Contest (“Contest”), you (“Participant”) agreed to be bound by the following Terms and Conditions:-

- The Contest is organized by GCH Retail (Malaysia) Sdn. Bhd. and Visa Worldwide Pte. Limited (“Organiser”).

  - Participants may submit as many entries as they wish within the Contest Period but each entry must be supported with the required Proof of Purchase. One (1) Proof of Purchase entitles Participants to one (1) contest entry.
