

IMPORTANT NOTICE

These updated Terms and Conditions (Version 1.1) shall take effect from 9th January 2020 and applicable for Week 5 of Weekly Prize Winners onwards.

TERMS AND CONDITIONS

Organizer & Qualifications

1. **"FUEL -YOOOH! MyDebit Je with your ATM Card!" ["Contest"]** is jointly organized by Petron Malaysia (Company No.: 196101000489(4527-V)) and Payments Network Malaysia Sdn Bhd (Company No.:200801035403 (836743-D)) (PayNet) **["The Organizer"]**.
2. The contest is open to all MyDebit Automated Teller Machine **["ATM"]** card members issued by MyDebit financial institution in Malaysia. The above mentioned card member must be a permanent resident in Malaysia or a Malaysian citizen who has a valid identification document/card during the Contest Period **["Participant"]**. The Participant must also have a valid account with any of the issuing bank and the account must be active with a good financial standing during the entire Contest Period until the completion of the redemption of Prize.
3. Individuals listed below are not eligible to participate in this Contest:

 - Register in Whoop App (one-time registration)

 - Each valid and complete entry must contain the following information:
 - i. Take a photo of the Proof of Purchase;
 - ii. Answer the contest question correctly and provided the necessary info;
 - iii. RETAIN: **BANK RECEIPT (original)** as proof of purchase.
 - Participant will receive an immediate acknowledgement upon submission.
 - Note: Every valid purchase worth RM5 and above (in a single transaction slip) will be given **ONE (1)** random serial number.
9. Participant may send more than ONE (1) entry. Every ONE (1) transaction slip (with purchase of RM5 and above made using MyDebit ATM card) is eligible as ONE (1) entry. Each transaction slip can only be used once. The Participant entries will be disqualified if the same transaction slip is used for more than ONE (1) time.

43. Any matter to the Personal Data relating to this Contest shall be governed by and dealt with in the Personal Data Protection Act 2010 and any relevant laws in Malaysia
