



TERMS AND CONDITIONS
BSN SIJIL SIMPANAN PREMIUM (SSP)
CUSTOMER DATA INFORMATION UPDATE CAMPAIGN

1. Campaign Period

The 'BSN SSP Customer Data Information Update campaign' ("Campaign") is organized by Bank Simpanan Nasional ("BSN") shall commence from **18 January until 31 March 2016**, both dates inclusive ("Campaign Period") unless notified otherwise.

2. Eligibility

- 2.1. The Campaign is open to all new and/or existing individual Sijil Simpanan Premium ("SSP") customer aged 12 years and above including non-citizens customer (with permanent address in Malaysia) ("Eligible Customer").
- 2.2. The following entities / individuals SHALL NOT BE ELIGIBLE to participate in this Campaign:
 - (a) Permanent and/or contract employees of BSN and its subsidiaries and/or related companies.
 - (b) SSP certificate belongs to the customer who passed away before the draw date.
 - (c) Individuals aged below 12 years.

3. Campaign Mechanics

- 3.1 Customer must fill-up Customer Data Information Update Campaign form ("Form") and submit at any BSN branch counter or through BSN promotion counter. Customer will then need to tear off the bottom part of the Form and drop it in the "Draw Box".
- 3.2 Selection of Winner for "Monthly Prize" will be conducted throughout BSN branches latest by the second week of the following month.
- 3.3 Selection of Winner for "Bonanza Prize" will take place at BSN main branches after the Campaign ended.
- 3.4 Customers will be selected randomly to make a draw from the "Draw Box" to select Winners for both the "Monthly Prize" and "Bonanza Prize".

3.7 Winners will be notified through Short Messaging System (SMS) and/or phone call. List of winners will be published at the BSN branches where the forms are submitted.

- 4.2. BSN reserves the right to substitute the prizes with any other item of similar value without giving prior notice to the winners.
- 4.3. BSN shall not be responsible or held liable in any manner whatsoever in respect of any loss, damage, delay, tampering, theft or modification of the Prizes.
- 4.4. Winners shall be responsible to pay any tax, incidental cost and/or other charges relating to any of the Prizes.
- 4.5. The Prizes are not exchangeable for cash or credit of any kind, in part or in full.
- 4.6. The determination of the winners is final. No correspondence, queries, appeals or protest will be entertained.

6. General

- 6.1. Eligible Customer and/or Winners hereby expressly provide consent to BSN, at its discretion, publishing and/or displaying materials and/or any information including but not limited to the names and/or photographs of the Eligible Customer and/or Winners for current and future advertising and promotional purposes in any manner that BSN deem appropriate.

BSN may give such notice or communication to Eligible Customer through any modes or methods as BSN deems appropriate including without limitation by posting at BSN's website, by post, by notification in the mass media, by posting the notice in the BSN's branches or by electronic transmission or any other method that BSN think appropriate.



- 6.4. In the event of any discrepancy between the T&Cs and any advertising, promotional, publicity and other materials relating to or in connection with the Campaign, the final T&Cs on BSN's Website shall prevail. Any matter with regards to the Campaign which is not covered in these T&Cs will be determined solely by BSN at its discretion.
- 6.5. BSN at its discretion may withdraw, cancel or suspend the Campaign earlier than the Campaign Period or extend the Campaign beyond the Campaign Period without giving prior notice to the customers.
- 6.6. BSN shall not be responsible and/or liable nor shall it accept any form of liability whatsoever nature and howsoever arising or suffered by Eligible Customer resulting directly or indirectly from the Eligible Customer's participation in the Campaign or otherwise. Furthermore, BSN shall not be liable for any default of its obligation under the Campaign due to any force majeure event which include but not limited to act of God, war, riot, lockout, industrial action, fire, flood, drought, storm or any event beyond the reasonable control of BSN.
- 6.7. These T&Cs shall be governed by the Laws of Malaysia and subject to the exclusive jurisdiction of the Courts of Malaysia
